The Republic of Serbia has received financing from the World Bank toward the cost of the Sava and Drina Rivers Corridors Integrated Development Program, and intends to apply part of the proceeds toward payments under the contract for Rehabilitation of the Sava River Left Bank from rkm 121+277 to rkm 123+350 near Jarak.
- 2. The Ministry of Agriculture, Forestry and Water Management Directorate for Water now invites sealed Bids from eligible Bidders for rehabilitation of the left river bank of the Sava River from rkm 121+277 to rkm 123+350 near Jarak Settlement. The construction period is 25 months, no margin of preference is applicable.

Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" July 2016, revised November 2017 and August 2018) ("Procurement Regulations"), and is open to all Bidders as defined in the Procurement Regulations.
